### 1. Identity and address of the person responsible for your personal data.

Of C.V. , Hereinafter "Mezcal Las Garrafas" in AVENIDA RODOLFO GAONA 86-E street in the LOMAS DE SOTELO Colony in the MIGUEL HIDALGO, C.P. 11200, MEXICO, CITY OF MEXICO, will be responsible for the personal data, the use of the same and their protection.

### 2. Personal data collected and processed.

It will be "Personal Data", your email and all the data that locate and identify it and that could provide the responsible such as name, surname, address, telephone, etc.

We inform you that we do not handle sensitive data in any way, so you should refrain from providing such data.

### 3. Purposes for which your personal data are collected and used.

### 6. Mechanisms for the holder to express their refusal to process their personal data.

If you do not agree with any of the uses listed above regarding the handling of your "personal data" we request you to express your refusal to do so through the means mentioned below to assert your ARCO rights, where In a term of ten business days counted from the receipt of such a request for denial, the reception of the request will be confirmed and we will abstain from the handling of the "personal data" in the terms restricted by the holder.

The temporality of the handling of the personal data would be until you make us the decision that your data is eliminated and until as long as it fulfills the purpose for which they were provided, of course you can oppose at any time that considers it appropriate . Once the personal data have been used for the aforementioned purposes, they will be canceled and blocked, preserving them only for safekeeping for a period of no more than 5 years from the effective use of the same, in consideration of the term Which the authorities have in order to exercise their powers of verification and supervision, and subsequently

destroy and / or delete their personal data provided that there is no request by a competent authority, which would interrupt the destruction's deadline.

#### 5. Transfer of your personal data.

For the above, you must tell us the personal data that you want to be rectified, canceled or reviewed, as well as the purpose for which you provided them, the date on which you provide them and, if possible, identify the person who delivered them to you, In general the requirements mentioned in art. 29 of the law. Through the means mentioned above you will also be able to know the procedure (s) for the exercise of ARCO rights.

#### 9. Means to limit the use or disclosure of personal data.

#### 10. Amendments to the Notice of Privacy.
